Educational Qualification and Experience:

- 1) **For Engineering Subjects:** Minimum ME/M. Tech in relevant branch of engineering & 1st class or equivalent either in BE/B. Tech or ME/M. Tech
- 2) **For Mathematics, Environmental Science & Communication Skill:** Post Graduation in appropriate branch or equivalent with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed). Besides fulfilling the qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET. However, candidates, who are, or have been awarded a Ph. D., are exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.
Or B.E./B.Tech. (First Class) with suitable branch in Post-graduation.
