Now this agreement witnesses as follows:-

1) Government College of Engineering, Aurangabad and SPV will nominate a nodal officer for effective interaction

2) Government College of Engineering, Aurangabad and SPV will work together to identify and find ways and solutions issues are broadens of technical managerial and financial nature college of the solutions of technical managerial and financial nature college.

- 3) Government College of Engineering, Aurangabad the resource institute and SPV will provide their input on technical process, technology up-gradation, new technology adoption, product R&D, field survey, IT base services and shall also provide advice on continuous improvements in the process involved.
- 4) Government College of Engineering, Aurangabad will provide relevant technical manpower including faculty and students to identify and address issues and problems
- 5) The SPV may not claim any ownership of the study research and solutions suggested by Government College of Engineering, Aurangabad.
- 6) Professional charges towards the services will be paid by the SPV to Government College of Engineering, Aurangabad for solutions and the same will be decided considering the quantum of work for type of services etc.
- 7) Government College of Engineering, Aurangabad will be free to assign the task of study research to their faculty, students as a part of their academic project/research works.
- 8) The facilities at the CFC will be made available to the students and faculty as per mutual agreed terms.
- 9) This agreement can be terminated by any party with a notice period of two weeks. Any clause of this agreement can be revised and deleted with mutual consent.
- 11) Any dispute related to any part of this agreement or any issue arising out of the arrangements stated in this agreement the parties shall solve with mutual understanding and consent.
