



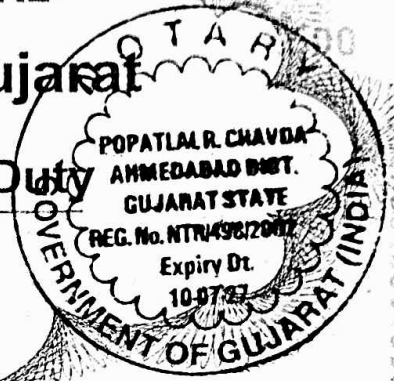

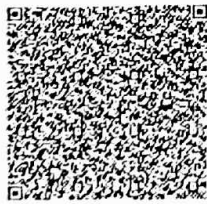

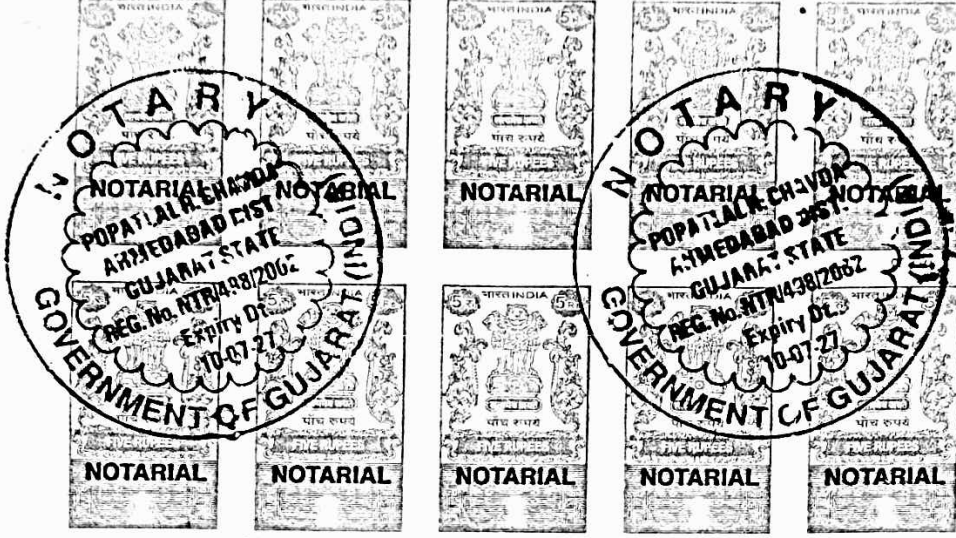

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is entered into at Naroda, Ahmedabad on this 20 day of February 2024 by and between:

Government College of Engineering Aurangabad, Chhatrapati Sambhajanagar, which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and include its successors, executors, administrators, legal representatives and permitted assigns of the
(FIRST PARTY)

AND

M/S Siemens Energy Industrial Turbomachinery India Pvt. Ltd. (Formerly known as Dresser-Rand India Pvt Ltd) incorporated under the Companies Act, 1956, having corporate identity number CIN no. U29100MH1998PTC117293 and having its registered office at Birla Aurora, Level 21, Plot no. 1080, Dr. Annie Besant Road, Worli, Mumbai 400030, Maharashtra Corporate Identity number: U29100MH1998PTC117293 and principal place of business at 187, GIDC, Naroda, Ahmedabad 388330. (hereinafter referred to as "SEITIPL") which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and include their successors and permitted assigns), of the
(SECOND PARTY)

Government College of Engineering Aurangabad, Chhatrapati Sambhajanagar, and **Siemens Energy Industrial Turbomachinery India Pvt. Ltd. (SEITIPL)** are individually referred to as a "Party" and collectively as "Parties".

WHEREAS:

- Government College of Engineering Aurangabad, Chhatrapati Sambhajanagar (GCEA) is allowed to take in kind donations from Siemens Energy Industrial Turbomachinery India Pvt. Ltd. (SEITIPL) by way of supply of **3D Printed Working Models** of reciprocating and centrifugal compressor models of Siemens' energy management solutions.
- The parties have mutually agreed to enter into this MOU with GCEA for supply of working models of compressors for setting up Turbomachinery Laboratory in Mechanical Engineering department.
- SEITIPL in order to support the Purpose, has committed under its CSR activities to provide 3D models of Reciprocating and Centrifugal Compressors (referred as equipment in this MOU) as prescribed in Annexure-I.
- This MOU is being entered into by and between GCEA and SEITIPL to record various terms agreed between the Parties, for the Purpose mentioned above.

A. Roles and Responsibilities of the Parties for the Purpose

1. Government College of Engineering, Aurangabad, Chhatrapati Sambhajnagar

(i) Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar shall have complete authority to allocate the Deliverables detailed in Annexure-I and the same shall be binding on GCEA to be used for the Purpose. (Mentioned in Annexure I)

(ii) Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar shall inform SEITIPL about the designated person who shall represent Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar for the purpose of coordination with SEITIPL team in relation to the setting up Turbomachinery Laboratory.

(iii) In case further funds are required towards capital expenditure for the Purpose during the MOU Period, the same shall be borne by Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar.

(iv) Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar, shall provide all assistance as may be required for the Purpose or the utilization of the Deliverables as mentioned in Annexure I.

(v) Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar, will take appropriate steps to take care of the Deliverables provided by SEITIPL as ascribed in Annexure-I.

(vi) Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar, to the extent possible to protect the interest of the SEITIPL and use the contributed deliverables as detailed in the Annexure-I. for Purpose as provided and for no other commercial purpose.

(vii) Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar shall not alienate the contributed Deliverables as detailed in the Annexure-I without prior intimation to the Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar, and SEITIPL.

(viii) Provision of working models of Siemens Energy Compressors for setting up Turbomachinery Laboratory.

- Government College of Engineering Aurangabad, Chhatrapati Sambhajnagar, accepts the equipment(s) being donated by SEITIPL as per the Annexure-I

2. Siemens Industrial Turbomachinery India Private Limited.

SEITIPL hereby agrees to provide funding and support the institute as follows:

(i) Provision of working models of Siemens Energy compressors as Refer in Annexure I

- SEITIPL shall bear the cost of equipment(s) as per Annexure-I and donate it to the institute.
- SEITIPL will ensure that the abovesaid equipment(s) are installed by the equipment(s) manufacturer / seller in the designated area in the Government College of Engineering Aurangabad, Chhatrapati Sambhajinagar as approved by the institute.
- The title of the equipment(s) shall pass on to the institute upon delivery of the equipment(s) at the institute's premises.
- SEITIPL will not bare any spares costs if needed for repair of the equipment and the same shall be borne by the Institute.
- Government College of Engineering Aurangabad, Chhatrapati Sambhajinagar shall interface with the equipment(s) manufacturer / seller to ensure that all safety precautions and practices are duly implemented while erecting, installing testing, and commissioning the equipment(s). SEITIPL shall not be held responsible for any lapses or its consequences, arising due to the breach of safety protocols by the equipment(s) manufacturer / seller.
- SEITIPL is a CSR donor of the equipment(s) to the institute. SEITIPL will not be held responsible for the quality of results and education reports of the training student conducted using these equipment(s).

(ii) Renovation / Refurbishment:

- SEITIPL will provide initial setup cost but would not renovate and refurbish each identified and designated area for setting up the equipment(s) as mentioned in Clause 2 (i) above if needed and same shall be responsibly of the Institute if required.

(iii) Timelines

- SEITIPL will make its best endeavour to complete the activities mentioned in Clause 2 (i) on or before 30th April 2024. However, in the unlikely event of non-fulfilment of the above timelines, no consequences or claims shall be entertained by SEITIPL in

(iv) The support provided by SEITIPL, as mentioned in Clause 2(i) above for the institute will be provided free of cost. SEITIPL will not receive any compensation or consideration in return for the support covered under this Donation letter / MOU.

B. Governing Law and Jurisdiction

- (i) This MOU shall be governed by and construed in accordance generally with the laws of India and specifically the designated tribunals / courts in Ahmedabad shall have exclusive jurisdiction to settle any disputes which may arise out of or in connection with this MOU.
- (ii) Dispute Resolution: - The Parties to this MOU hereby agree that they intend to discharge their obligation in utmost good faith. The Parties therefore agree that they will at all time, act in good faith, and make all attempts to resolve all differences howsoever arising out of or in connection with this MOU by discussion
- (iii) The terms of this MOU shall be subject to the Regulations, or any amendment enacted thereto from time to time.

C. Force Majeure

None of the Parties shall be held responsible for non fulfillment or delay of their respective obligations under this MOU due to the exigency of one or more of the force majeure events such as acts of God, war, riot or Civil commotion, fire, flood or earthquake, or other natural physical disaster; any restrictions imposed by the Government or other Statutory bodies which prevents or delays the execution of the MOU by one or more of the Parties or occurrence , any event beyond the control of the Parties to the MOU. Upon occurrence of any force majeure event, the Party so affected shall promptly notify the other Party in writing specifying the nature of the Force Majeure and of the anticipated delay in the performance of the MOU. From the date of the notification, SEITIPL shall at its discretion, either terminate the MOU forthwith or suspend the performance of the MOU for certain period.

D. Other

- (i) Amendments and additions to this MoU must be made in writing. The written form cannot be replaced by the electronic form.
- (ii) Siemens ENERGY shall not be obligated to fulfil this MoU if such fulfilment is prevented by any impediments arising out of national or international foreign trade or customs requirements or any embargoes or other sanctions or change of any internal policies or financial condition of SEITIPL, which shall be duly notified to the Institute.



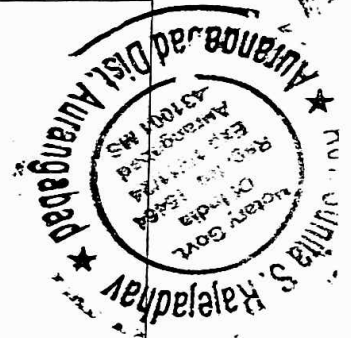


The PARTIES undertake to cooperate in accordance with the principles of good faith and in particular to refrain from any action which might damage the reputation of the other PARTY.
