Item 1: Welcome address by Principal.

The Chairman of the Senate and Principal have announced commencement of VI Senate and welcomed all honorable members. The Principal had informed the Senate about the program and development of the Institution during last year.

Item 2: Confirmation of minutes of V Senate

Minutes of V Senate were noted as read page wise and approved.

Item 3: Action taken report on minutes of V Senate

Action taken report on V senate is read Para wise, noted & approved.

Item 4: Proposal from various Department Subject Boards

- 4. a. Proposal from DSB in Electrical Engineering was noted and approved.
- **4. b.** Proposal from DSB in Electronics Engineering was noted and approved subject to following corrections: ME (EC) ET503 Instrumentation and Control should be renamed as Advanced Instrumentation and Control.
- **4. c.** Proposal from DSB in Computer Science and Engineering was noted and approved with the following suggestion: Hon. Members had suggested that elaborate syllabus should be prepared for CS538 Elective II and the concerned DSB should take necessary action.
- 4. d. Proposal from DSB in Information Technology was noted and approved.
- **4. e.** Proposal from DSB in General Engineering was noted and approved with following suggestion: Engineering Maths IV- The department of Mathematics had suggested to provide 4 lectures per week for Engineering Maths IV uniformly for all branches. It is decided that the number of credits allotted to a specific subject should be uniform. However, regarding Engineering Maths IV matter should be referred to respective DSB's, to decide whether this subject is required for their students and if required shall prepare course content as per the requirement of their discipline.

Item 5.1: Proposal from Dean (R&D)

5.1.a Approval of new Research Guides

The proposals for Recognition of Research Guides in Civil, Electronics, Mechanical, Electrical and Structural Engineering were noted & approved.

5.1.b. Approval of Registration of new Research Students

The Proposal for Registration of Research students in Civil, Electrical, Mechanical,

Electronics & Structural Engineering were noted and approved.

Dr. Narayan Khedkar had questioned the rationality of number of students allotted to Research Guide in Electronics Engineering. Dr. U.J. Kahalekar had suggested that each registration for Ph.D. course should accompany a Research proposal which was accepted by the Senate & directives in this regard shall be issued to all Research Guides. Allotment of additional one Research student to Dr. D.G. Regulwar is accepted and approved.

Item 6: Transfer of Ph.D. candidates from Electrical Engineering to Electronics Engineering.

The proposal was objected by member Prof. R.P. Chaudhari on the ground that there is no such provision in Ph.D. rules neither this practice is followed anywhere in any institute. However Prof. P.S. Revankar had pointed out that the Chairman of the Senate has all the powers to take the decision in any matter. On this grounds, the Chairman Dr. W.Z. Gandhare had approved the transfer of Ph.D. candidatures.
