2.1 Syllabus of Final Year Engineering from academic year 2015-16

Proposal for approval of structure, syllabus and examination scheme of IV year (B. E.) of under graduate program Full time / Part time in Civil Engineering, Computer Science & Engineering, Electrical Electronics & Power Engineering, Electronics & Telecommunication Engineering, Information Technology and Mechanical Engineering.

In order to provide resilience for outcome based curriculum it was suggested for approval that Assessment Pattern provided in curriculum of all courses for every program are recommended pattern. Program coordinator and course coordinator has the flexibility of small deviations in defining assessment pattern.

The proposal was discussed at length and many members actively participated in discussion. It resolved that it is approved w.e.f. 2015-16 and program coordinator and course coordinator has the flexibility of defining assessment pattern. It is discussed to adopt choice based credit system from year 2015-16 for first year. It is directed to prepare first year syllabus according to the system and to be approved in next academic council.

2.2. Proposal for approval of change of course codes for T.E. Electronics & Telecommunication Engineering.

It was resolved that change of course codes for T.E. Electronics & Telecommunication Engineering is approved w.e.f. 2015-16.

3.1 Syllabus of Second Year Master in Engineering and third year M.C.A. from academic year 2015-16

Proposal for approval of structure, syllabus and examination scheme of second year M. E. program Full time / Part time in Civil Engineering, Computer Science & Engineering, Electrical Electronics & Power Engineering, Electronics & Telecommunication Engineering, Mechanical Engineering, Structural Engineering Department and Third year M.C.A. Department.

The proposal was discussed at length and many members actively participated in discussion. It resolved that it is approved w.e.f. 2015-16 and program coordinator and course coordinator has the flexibility of defining assessment pattern. It is discussed to adopt choice based credit system

from year 2015-16 for first year. It is directed to prepare first year syllabus according to the system and to be approved in next academic council. The syllabus of environmental studies is approved. (5)

3.2 Proposal for quality improvement of PG Dissertation.

1. The evaluation of dissertation at the time of pre submission viva voce shall be done by a departmental Committee comprising of guide and at least two faculty members from same discipline. Final viva voce shall be open viva- voce preferably on working days.
2. The P.G. candidate should publish first authored paper before submission of soft bound copy of the dissertation report.
3. All P.G. students who are doing their dissertation have to submit final soft bound copy of dissertation report a day before the start of end semester theory examination. Those who will fail to submit, with the permission of guide, they can submit up to start of re-examination otherwise they have to take readmission in next semester (by paying fees of Rs. 14500/-) as per institute circular.
Final viva voce examination will be conducted during the practical examination session of ESE/Re-ESE as the case may be.
4. Dissertation copy shall be submitted in soft bound form. The suggestions/modifications suggested by external examiner at the time of viva- voce should be incorporated and then final hard bound copy will be submitted. Date of declaration of result is the date of submission of hard bound copy.

The proposal was discussed at length and many members actively participated in discussion. It is resolved that

1. The evaluation of dissertation at the time of pre submission viva voce shall be done by a departmental Committee comprising of guide and at least two faculty members from same discipline. Final viva voce shall be open viva- voce.
2. The P.G. candidate should publish first authored paper before submission of soft bound copy of the dissertation report.
3. Dissertation copy shall be submitted in soft bound form. The suggestions/modifications suggested by external examiner at the time of viva- voce should be incorporated and then final hard bound copy will be submitted.

It is resolved that from 2015-16, Ph.D.process shall be carried out in Dr.B.A.Marathwada University, Aurangabad and to sort out the issue of admitted candidates till the date, special meeting with concerned officials of Dr.B.A.Marathwada University, Aurangabad will be arranged immediately by officials of Dr.B.A.Marathwada University, Aurangabad. Admission under QIP scheme shall be exception to this. Accordingly Hon. Vice-chancellor shall guide regarding the execution of processes to be followed in future with due cognizance of letters issued to the institute by U.G.C. and affiliating Dr.B.A.Marathwada University, Aurangabad. Members of academic council expressed that all previous approvals by RRC at Institute levels, could be acceptable, however they suggested to avoid repetition for conduct of RRC in the institute in future.

Minutes of meeting of Examination committee dated 9th April 2015


Minutes of meeting of Examination committee dated 9th April 2015 were noted.
