Advertisement for Recruitment of Adjunct Faculty

The institute has been granted autonomous status since 2006 and is affiliated to the Dr. Babasaheb Ambedkar Marathwada University.

To reinforce the teaching, learning and research excellence at Government College of Engineering Aurangabad, Chhatrapati Sambhajinagar, applications are invited in the prescribed format for Adjunct Faculty positions from highly motivated and eligible candidates separately for each discipline. Eligibility:

An Adjunct Faculty shall be a interested experienced qualified / retired faculty from Technical Institution / University with Post Graduation qualification in relevant discipline (preferably PhD) <u>**OR**</u> a person of eminence with or without a Post Graduate or PhD qualification. The candidate should have minimum 10 years of experience from Industry / Organization / Research / Academics. Although upper age limit for Adjunct Faculty is 65 years but there is no bar as long as he / she add value to the Education and academic activities of the Institute.

Function:

Functions of Adjunct Faculty / Resource person from Industry are:

- a) Teaching Technical Course(s): Adjunct Faculty shall be expected to teach Course(s) directly related to his / her specific expertise and professional experience or the areas of his / her specialization. He / She shall also contribute to the Institution's activities like counseling students, developing new course(s), guiding projects, and pedagogical improvements, etc..
- b) **Participation in service-related activities:** Adjunct Faculty is also expected to actively participate in service-related activities, such as working on Departmental Committees,

serving as advisors to Faculty and / or Under Graduate and Post Graduate students, helping students network, and active collaboration with the Industry / Employer providing internship and job opportunities. Adjunct faculty will be associated in R&D activities, consultancy, organizing various events and other outreach activities.

- 2. A single PDF file with a maximum size limit of 10 MB is to be created including the latest resume with the passport size digital photograph of the candidate, scanned copies of certificates / documents related to qualifications, professional experience (if any), achievements / awards (if any). This single PDF file is required to be uploaded in the online Google form.
- 3. A single PDF file containing brief write-up (max 2 pages) about your potential contribution to the institute. This single PDF file is required to be uploaded in the online Google form.
- 4. The last date for the receipt of the **ONLINE** application Google form is **25th July 2024** till 5:00 p.m.
- 5. The candidate should submit the online application Google form, upload the three separate PDF file including all necessary scanned copies of documents / certificates.
- 6. Candidates must also bring all the relevant original certificates / documents along with photo ID proof for verification at the time of scrutiny / interview. The hard copies of duly filled in application with signature and self-attested photograph with all required self-attested copies of the certificates / documents will have to be submitted at the time of scrutiny / presentation to the Institute authorities.
- 7. Candidates who wish to apply for more than one discipline should submit separate applications.

Selection Procedure:

- Eligible shortlisted candidates will be called by e-mail (provided in the Google Form by candidate) to appear for Round I. The date and venue will be communicated via email.
- Round I Scrutiny / Presentation at the respective Department (based on Subject knowledge and skills). Candidate has to attend the selection round in person.
- Shortlisted candidates in round I will be eligible for Round II.
- Round II Personal Interview at Institute level.
- Selected candidates will be communicated by email.

Other Terms and Conditions:

- 1. The educational qualifications and experience of respective discipline will be as per the latest norms of AICTE / UGC / Government of Maharashtra resolutions published time to time and duly approved by Board of Governance (BoG) of the institute.
- 2. The appointment is purely on a temporary basis for academic session 2024-25 with a consolidated salary of Rs. 75,000/- per month (under revision). Interested and passionate candidates, who are retired from Government Institutions / Organizations, and having exceptional and extraordinary candidatures, will be recommended to Board of Governance for the pay minus pension scheme approved by Board of Governance.
- 3. Services shall stand automatically terminated; on expiry of the tenure or if the performance

of the selected candidate is not satisfactory on review after every quarter of the service.

- 4. If the services of any candidate are not found satisfactory, his / her services may be terminated forthwith without mentioning any reason to him / her.
- 5. Mere fulfillment of minimum qualification and experience requirements does not entitle the candidate to be called for an interview. A short-listing criterion may be set higher than the minimum.
- 6. No TA / DA are admissible and will not be paid to the candidate to attend a scrutiny / presentation and interview.
- 7. Any misleading or wrong information provided may lead to summarily rejection of application / appointment, if found subsequently. Canvassing in any form by or on behalf of a candidate will lead to disqualification.
