

The applicant Mr. Maitreya Ganeshpure (S.E. ENTC Roll No. BE21F04F018) and Non applicant Mr. Pruthviraj Balwat (T.E. Electrical Engg. Roll No. BE21S03F002) were called to present their say in front of the committee. The eye witnesses Mr.Rushikesh S. Panchal (T.E. Electrical Engg.), Mr. Atharva Pravin Shete (SE ENTC Engg.), and Mr. Piyush Ambadas Deogade (TE Electrical Engg.) were called. They have given their statement in front of the committee in oral & in writing.

The applicant and non applicant were unknown to each other before this incidence. The applicant & all witnesses told that the incident happened outside the campus of Institute on 11th April 2023 at around 9.00 pm. Both applicant and non applicant are members of Anuradha Mess (Privately run by Mr. Jaiswal near college campus). The applicant and all witness told that it is not the case of ragging and it was the misunderstanding between applicant and non applicant about loss of footwear by applicant at mess on 01st of April 2023. The applicant has agreed to withdraw his complaint & they both agreed to close the case unanimously. They said sorry to each other & given in writing that they will not continue this matter or misunderstanding in future. There will not be any problem to each other in any matter.

Considering the statements of applicant, non applicant & eye witnesses, committee came to a decision that the incident report by the applicant do not came under ragging & it was a clear case of misunderstanding. Both Police authorities & Principal carried out the counseling of both applicant & non applicant.
